## **ANNUAL REPORT 2024-25: DISABLED WAR VETERANS (INDIA) REGD**

### **Introduction**

1. Disabled War Veterans (India) popularly known as DIWAVE was founded in 1978 and registered with Registrar of Societies vide Regd No 9904 dated 14 Dec 1978. It is one of 5 organisations granted recognition by the Government of India, Ministry of Defence, vide letter No 2(2)/DIWAVE/KSB/2004 dated 10 Nov 2004 and No 28(145)/2019/D(Res 1) dated 16 Sep 2019. In real sense, this is the only active organisation of War Disabled / Battle Casualties. It is a non-political, democratic, secular and voluntary organisation.


2. DIWAVE was as a result of the initiative taken by Capt. Narinder Kumar Mahajan, a 100% War Disabled Soldier of 1971 Bangladesh Liberation War, who while admitted in Army Hospital R & R, felt the need to resolve some issues relating to the welfare of War Disabled Soldiers, but found the existing organisations inadequate for the task. He joined hands with Late Maj. Vijay Kumar, VrC, a War Disabled Soldier of Indo-Pak War 1965 to set up the new Organisation.

3. Disabled War Veterans (India) has been formed to help all members of the Indian Armed Forces who are War Disabled, invalidated out of service as well as retained in service as also their dependents. DIWAVE has following two types of members :-

- (a) Life members -1440
- (b) Associate members -9117

4. DIWAVE's Mission is to reach out to every War Disabled Soldier/ Battle Casualty including those living in remotest corners of the country. DIWAVE has been contacting and approaching War Disabled Soldiers / Battle Casualties through letters, messages and mails with a view to enrolling them as members and strengthening the Organisation. It has succeeded to a large extent in its objective but still a lot of work remains to be done.

### **Aim**

5. The Aim of this organisation is to reach out to every War Disabled Soldiers /Battle Casualty to address their difficulties in day-to day life and any other issues cropped up affecting them. The organization is committed passionately to help them.

6. It is nice that martyred are remembered always, whereas War Disabled Soldiers / Battle Casualties is a forgotten lot and live life in anonymity.

### **Sad Truth**

7. When a Soldier is martyred, a family dies. There is no monetary benefit that can glue that family together. When a Soldier becomes a War Disabled, a family dies every day. Someone will scratch upon the wound of disability and kill the hopes of the family.

8. DIWAVE has faced many constraints such as paucity of funds, lack of office space, lack of staff etc. It is functioning only with the donation of the War Disabled members and a few well wishers. It doesn't get any funds from the Govt or other organisations. Thanks to generous donation by Smt. Karuna Pandit w/o Late Major Vijay Kumar VrC, DIWAVE now has its own office space at C6-18/1, Ground floor, Safdarjung Development Area New Delhi-110016.





- (a) Reaching out to Disabled War Veterans in remotest corners of the country where Govt agencies lack connectivity.
- (b) Restore doubts of pensioners on policy letters by providing clarification on OMs/ Circulars issued by various Govt/ Armed Forces departments as well as information and guidance on pension, medical treatment and other retirement related matters.
- (c) DIWAVE is regularly making a valuable contribution for circulating the OMs, orders guidelines issued by the Department through print media, whatsApp groups and other means.
- (d) DIWAVE facilitates redressal of pensioner's grievances by registering their grievances on grievance portal and liaise with offices of Government of India (PCDA)/Record offices w.r.t. pensioners' grievances.
- (e) DIWAVE plays an active role in helping pensioners to submit Digital Life Certificates. For this purpose DIWAVE assists concerned banks to visit old/ sick/incapacitated pensioners at their homes/old age homes and at the hospital.

## Major Achievements.

11. Following major achievements:-

- (a) Separate Identity cards for War Disabled Soldiers are being issued.
- (b) War Disabled Soldiers are exempted from ECHS Charges.
- (c) ECHS cards with annotation **WAR DISABLED** have been issued which entitles priority treatment in ECHS Polyclinics to battle casualties & their spouses.
- (d) Priority for treatment in OPDs and admissions in Armed forces hospitals.
- (e) Broad-banding of Disability which has given legitimate financial security.
- (f) Removal of cap on war injury pension. Service Element plus war injury element was earlier restricted to maximum of basic pay i.e. 100%.

- (f) Upgrading the ward for War Disabled Veterans / Battle Casualties in Empanelled Hospitals.

13. **Create Awareness of Govt Policies for War Disabled Soldiers.**



- (a) Display of Sign Board: Priority treatment of War Disabled / Battle Casualties in each and every ECHS Polyclinics.
- (b) Reduction of staff in ECHS Polyclinics: Results fatigue harassment & Demoralizing to beneficiaries.
- (c) ECHS card with Annotation "**War Disabled**".
- (d) Refund of ECHS Membership amount charged from War Disabled Soldiers.
- (e) Upgrading the Ward for War Disabled Soldier Soldiers / Battle Casualties and their spouses.

**(f)** Problem faced by War Disabled Soldiers / Battle Casualties due to new software.

- (g) Local Purchase, Procedure for NA medicines and other arbitrary practices.
- (h) Issue of Repair of Prostheses.
- (j) Revision of rates for procurement on purchase of hearing aids.
- (k) Priority for employment for wards for war disabled soldiers in ECHS.

- (a) **Introduction Of Badge For War Disabled Soldiers / Battle Casualties.** **DIWAVE** has requested to AG introduce a badge appropriately designed for War Disabled Saddlers / Battle Casualties.
- (b) Implementation of Order No 200847/Pen-C/1971 Dated 24 Feb 1972.
- (c) Priority for Reservation /preference to the wards of Armed forces personnel by states /UTs for admission to medical /professional /non professional courses.
- (d) Reversing the priority for Wards of War Disabled / Battle casualty retained in service.
- (e) Extend invitations to the War Disabled / Battle casualties and ensure separate enclosures for them in Armed Forces and National functions.

**29. Solved cases of DIWAVE Members in 2024.**

- (a) **DIWAVE** has taken up case for the refund of ECHS amount (Rs. 67000/-) charged from No 2602464A Hav Eranna M of 9 Madras. He got his refund of ECHS amount and confirm in Feb 2024.
- (b) After a long correspondence by **DIWAVE**, No. 5454925M NK Raju Thapa received his War Injury element as per his entitlements and arrears of war injury element amount Rs 10,63,814/- has been granted on 20 May 2024.




(c) **DIWAVE** has taken up a case regarding non reflecting War Injury Elements in the PPO of No 14804038Y Ex NK Aswar Ganesh Shriram with PCDA (P). A Corrigendum PPO duly reflecting War Injury Element has been issued to the individual on 02 April 2025.

(d) **DIWAVE** have received an application along with required documents for financial assistance for daughter marriage grant in r/o No 3385990M Sep Shamsher Singh of Sikh Regiment. **DIWAVE** has written to R & W section DIAV for the same. **DIWAVE** received confirmation from R & W Section vide letter no B/45391/Gen/AG/R&W on 25 April 2025 His application is now being progressed for verification by section maintaining the database. Thereafter, his name will be included in payment list.

(e) **DIWAVE** has received an application from Ex NK Farmaji Variva regarding deduction in pension without intimating any reason. **Diwave** has approach to all concern departments. Refund of recovered amount Rs. 100758/- has paid on 07 April 2025.
