- 3 To render help to the dependents of such disabled and dependents of man killed in war in getting good education, etc.
- 4 To ensure, in close cooperation with the authorities, that proper medical care is given to the war disabled and their families, as well as ensure help in physical rehabilitation, where required.
- To endeavour to educate the public, by holding seminars, periodic conferences, Exhibitions etc. of the part played by the War Disabled Association in their service and after-service lives.
- To promote the above aims and objects by establishing State Units/Bodies of this Association throughout the country in times to come.
- 7 To collect subscriptions, donations etc. in cash or kind, through lawful means, for the purpose of furthering the aims and objects of the Association.
- 8 To invest and deal with the moneys of the Association in such securities or manner as may, from time to time, be determined.
- 9 To raise loans from any person or persons, local authority or Government so as to create funds for the Association.
- 10 To sell, improve, develop, manage, lease, mortgage, charge, dispose of and otherwise deal with all or any part of the property of the Association, whether movable or immovable.
- 11 To cooperate with or absorb any other institution or society having similar objects to those of DIWAVE.
- 12 To perform such lawful acts as would be conducive to the achievement of the objects of this Association.
