  - 4. PRIORITY FOR RESERVATION / PREFERENCE TO THE WARDS OF ARMED FORCES PERSONNEL BY STATES / UT'S FOR ADMISSION TO MEDICAL /PROFESSIONAL / NON-PROFESSIONAL COURSES.
  - 5. REVISING THE EDUCATION GRANT
  - 6. CONSTANT ATTENDANT ALLOWANCE
  - 7. LIBERALIZED PENSION FOR THE WIDOW OF THE WAR DISABLED
  - 8. STANDBY PROSTHESIS

#### 1. DIWAVE has again written reminders for all matter given below:

- 1. Issue of Free Fast Tag to all the War Disabled Soldiers / Battle Casualties.
- 2. Entitlement of Four Wheelers through CSD to all War Disabled Soldiers / Battle Casualties. There should not be a normal gap of eight years applicable now between two car purchases.

DIWAVE hopes that they will understand the requirement of War Disabled Soldier and issue necessary amendment accordingly.

- 2. Case for "PRIORITY FOR ADMISSION IN PROFESSIONAL COURSES & MEDICAL COLLEGES FOR WARDS OF WAR DISABLED RETAINED IN SERVICE' filed in High Court case has been listed now on 16 Jan 2025
- 3. Enhanced / Liberalized pension for the Widows of War Disabled Soldiers / Battle Causalities WP(c) 14747/2023. The case has been listed now on 05 Dec 2024.
- 4. "Exemption of Income Tax for War Disabled Soldiers / Battle Causalities retained in Service" has been fixed for hearing is on 18/12/2024

# 1. <u>REQUEST TO PROVIDE ASSISTANCE TO WAR DISABLED SOLDIER / (BATTLE CASUALTY)</u>

Diwave has received copy of a letter from No 15318761Y Spr K A Subbaiah ( a War Disabled Soldier ). As per Govt Sechme and Hon'ble High Court Karnataka he was allotted a waste land measuring 5 acres in survey No 22/1 at Chikkaluwara (Vill), Kadagu Karnataka on Feb 2024.

On Jun 2024 he was abused by local peoples, Sub Inspector saying that this land belongs to Kodagu University.

Diwave wrote letter to Hon'ble Revenue Minister and Concern authorities to take necessary action and help the War Disabled Soldier.
